There will be no qualification if less than 8 units in categories (IW/IM/MP/TR/GR).</p> <p><b>FINALS:</b> National Development, Age Group, Juniors and Seniors: Each final (IW, IM, MP, TR, GR): maximum of ten (10) units: 7 best foreign units (max. 2 per nation) + 3 Slovak units (maximum).</p>

The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
<b>COVID-19 FIG GUIDELINES</b>	The <a href="#">FIG Medical Guidelines for FIG Competitions and Events</a> are still effective and they should be used according to the situation with COVID-19 pandemic in your country. Considering the current situation as it is written in the guideline, it is the health situation in your country that prevails. <b>"These guidelines can be adapted according to the health situation related to the COVID-19 pandemic in the host country and the city."</b> All delegation must bring Negative PCR test results 48h before the time of arrival in Slovakia. LOC is cooperating and consulting with the Slovak health authorities. All participants have to follow the Anti-Covid measurements. The Heads of the Delegations and the coaches are responsible for their delegation's members.
